# Licensing Inspection Report (Annual Inspection)

## **Requirements resulting from licensing inspection:**

**1**. HSCR 38(5)(b)

The administrator of a home for special care licensed by the Minister of Health and Wellness may authorize a resident to store drugs locked in the resident's room if the requirements set out in policy and standards for the home are met.

**2**. LTCPR 9.2.10

The licensee shall ensure a written record for fire drills and exercises outlined above, that includes the date, time, location, staff attendance, response times, outcomes, areas for improvement, remedial actions and debriefing, is maintained by the licensee.

## **3**. LTCPR 9.2.1.d

The licensee shall ensure external observers, such as individuals experienced in dealing with emergency situations, are invited to the exercise and asked in advance to provide feedback regarding exercises, testing and debriefing.

- 4. HSCR 20A(1), LTCPR 9.1.2 The licensee shall ensure a labour disruption contingency plan, which may be included in the business continuity plan, is developed in consultation with service partners as appropriate.
- **5**. LTCPR 8.5.12

The licensee shall ensure MARs are reviewed and double-checked for accuracy by two authorized staff members before being utilized.

# 6. LTCPR 6.3.3

The licensee shall ensure the care conference results in a mutually agreeable, documented plan of care.

# **7.** LTCPR 8.4.3

The licensee shall ensure a stand-alone Infection Prevention and Control Committee is implemented or infection prevention and control issues/practices are included as a standing agenda item on another appropriate committee. The committee shall be multidisciplinary ensuring that the infection prevention and control program is regularly reviewed and revised to reflect leading practices and provincial direction.

#### **8**. LTCPR 12.1.6

The licensee shall ensure hazardous products that may be harmful to residents are secured at all times and are not accessible to residents. They are stored and disposed of in accordance with established safety practices/manufacturers' recommendations.

#### **9**. HSCR 38(5)(a)

The administrator of a home for special care licensed by the Minister of Health and Wellness may authorize a resident to store drugs locked in the resident's room if the resident's care plan or treatment plan contains a written clinical assessment authorizing the storage.

#### **10.** LTCPR 6.1.3

The licensee shall ensure results of assessments are documented on the resident record, are communicated appropriately to staff and become the basis for the resident plan of care.

## **11.** LTCPR 6.5.2.a

The licensee shall ensure the following processes are developed and followed: identification and communication of residents' food allergies, preferences, therapeutic diets, food textures, supplements and food contraindications.

#### **12.** LTCPR 6.5.2.c

The licensee shall ensure the following processes are developed and followed: labeling of food in refrigerators and discarding of expired food.

## **13.** LTCPR 6.7.2.c

The licensee shall ensure a recreational program is developed and implemented that is flexible, innovative and varied to respond to the residents' leisure needs and interests.

#### **14.** LTCPR 8.2.3.d

The licensee shall ensure risk management processes that minimize risk to residents and staff are implemented. These include but are not limited to a process for analyzing critical incidents and adverse events, a minimum of quarterly or more often as required, to identify trends and ensure appropriate action is taken to remedy the identified risks.

# **15**. LTCPR 10.2.8

The licensee shall ensure residents' financial records are maintained in a safe and secure manner, are separate from resident care records and are maintained in accordance with Canada Revenue Agency requirements.

## **16**. LTCPR 8.4.12

The licensee shall ensure staff influenza immunization rates, in homes with greater than 5 employees, are posted in a public place and updated a minimum of twice per year on December 15th and on March 1st.

# **17**. LTCPR 8.4.10

The licensee shall ensure if bars of soap and other personal care items are used in resident rooms, they are designated for the use of one resident and are not shared.

# **18**. HSCR 27(7), LTCPR 9.2.4.b

The licensee shall ensure fire drills are conducted a minimum of monthly in accordance with direction from the Office of the Fire Marshal.

# **19**. LTCPR 7.1.12

The licensee shall ensure required inspections of the home and equipment are completed and documentation is maintained to demonstrate compliance with requirements. These include, but are not limited to, manufacturer requirements, safety requirements, sprinkler systems, water testing, fire alarms and fuel systems.

# **20**. LTCPR 8.1.5

The licensee shall ensure a process is in place to review the results of the satisfaction surveys and to develop and implement appropriate changes.

## **21**. LTCPR 11.1.8

The licensee shall ensure formalized performance management processes that evaluate staff members' performance annually, and more frequently as necessary, are in place.

## **22**. HSCR 38(5)(a)

The administrator of a home for special care licensed by the Minister of Health and Wellness may authorize a resident to store drugs locked in the resident's room if the resident's care plan or treatment plan contains a written clinical assessment authorizing the storage.

## **23.** LTCPR 7.2.6

The licensee shall ensure minutes of resident council meetings are maintained and include resolution or action on identified concerns or issues. Minutes are available and easily accessible for viewing by residents.

# 24. LTCPR 9.2.3.a

The licensee shall ensure there is a documented Staff Call Back Plan that includes: current staff phone numbers, procedure for staff call back, priority for contacting staff and how long it will take staff to arrive on site.

# **25.** LTCPR7.2.4

The licensee shall ensure the administrator attends resident council meetings a minimum of quarterly.
