## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of the Nova Scotia Health Authority:

### **Report on the Statement of Compensation**

I have audited the accompanying statement of compensation for the Public Sector Compensation Disclosure Act of the Nova Scotia Health Authority, for the year ended March 31, 2017, and a summary of other explanatory information. The statement of compensation has been prepared by management based on Section 4 of the Public Sector Compensation Disclosure Act.

### **Management's Responsibilities for the Statement of Compensation**

Management is responsible for the preparation of the statement of compensation in accordance with Section 4 of the Public Sector Compensation Disclosure Act, and for such internal control as management determines is necessary to enable the preparation of the statement of compensation that is free from material misstatement, whether due to fraud or error.

### **Auditor's Responsibility**

My responsibility is to express an opinion on the statement of compensation based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the statement of compensation is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the statement of compensation. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the statement of compensation, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation of the statement of compensation in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the statement of compensation.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

### **Opinion**

In my opinion, the financial information in the statement of compensation for the Public Sector Compensation Disclosure Act of the Nova Scotia Health Authority for the year ended March 31, 2017 is prepared, in all material respects, in accordance with Section 4 of the Public Sector Compensation Disclosure Act.
