Basis of Reporting

- ii. The value of loan or loan-interest obligations that have been extinguished and of imputed-interest benefits from loans,
- iii. Long-term incentive plan earnings and payouts,
- iv. The value of the benefit derived from vehicles or allowances with respect to vehicles,
- v. The value of the benefit derived from living accommodation provided or any subsidy with respect to living accommodation,
- vi. Payments made for exceptional benefits not provided to the majority of employees,
- vii. Payments for memberships in recreational clubs or organizations, and
- viii. The value of any other payment or benefit prescribed in the regulations.
