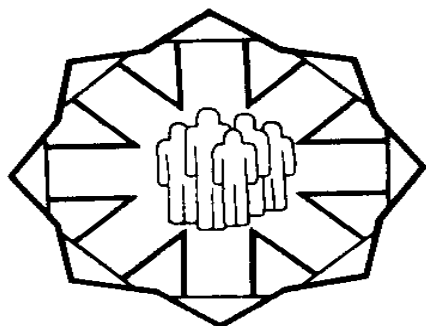
We confirm Ms. Wilkie's compensation and benefits for the year ended March 31, 2021 was \$105,511.
